The Board of Health of the Clermont County General Health District met in regular session on the 14th day of August, 2019, with the following members present:

Mr. Crum moved for adoption of the following resolution:

RESOLUTION ESTABLISHING A SPORTS PHYSICAL/STUDENT WORK PERMIT PHYSICAL FEE PURSUANT TO OHIO REVISED CODE SECTION 3709.09 AND 3709.21.

WHEREAS, the Board of Health of the Clermont County General Health District has the authority pursuant to Ohio Revised Code Section 3709.09 and 3709.21 to establish a uniform system of fee services; and

WHEREAS, the Board of Health of the Clermont County General Health District is mandated to provide services that protect the public health and prevent or restrict disease, and abate or suppress nuisances; and

WHEREAS, the Board of Health of the Clermont County General Health District strives to improve Clermont County by preventing disease, promoting health and protecting the environment; and

WHEREAS, the Board of Health of the Clermont County General Health District has determined that it is necessary to charge a fee for Sports Physicals/Student Work Permit Physicals.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Health of the Clermont County General Health District, that the fee for Sports Physicals/Student Work Permit Physicals be established at \$35.00.

Self-Pay Discount

All Sports Physicals/Student Work Permit Physicals are self-pay and there is no self-pay discount.

Financial Hardship

Financial hardships may be granted to patients less than 250% of the Federal Poverty Level (FPL) for Sports Physicals/Student Work Permit Physicals:

Family Gross Income as % of FPL	Discount
100% or less	0%
100 – 137.49%	20%
137.5 – 174.99%	40%
175 – 212.49%	60%
212.5 – 249.99%	80%
50% or greater	100%

NOW, THEREFORE, BE IT FURTHER RESOLVED, that all fees revised pursuant to this Resolution hereby become effective on September 1, 2019.

NOW, THEREFORE, BE IT FURTHER RESOLVED, by the Board of Health of the Clermont County General Health District, that these fees be published in one newspaper of general circulation that is in the Clermont County General Health District once a week for two consecutive weeks and that the first publication take place no later than 10 days prior to the effective date of the revision adopted herein.

NOW, THEREFORE, BE IT FURTHER RESOLVED, by this Board of Health of the Clermont County General Health District hereby finds by a vote of three-fourths (3/4) of its member that this resolution be read only once and that the requirement that it be read on three different days hereby be dispensed with as provided by law.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that this Board of Health of the Clermont County General Health District find and determine that all formal actions relative to the passage of this resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance of the applicable legal requirements, including section 121.22 of the Ohio Revised Code.
