Dr. Khan moved for the adoption of the following resolution:

RESOLUTION TO REVISE LOCAL AIR POLLUTION CONTROL REGULATIONS

WHEREAS, the Board of Health of the Clermont County General Health District has the authority, pursuant to Ohio Revised Code Section 3709.01, to adopt such regulations as are necessary for the public health, the prevention or restriction of disease, and the prevention, abatement or suppression of nuisances; and

WHEREAS, as provided for in Ohio Revised Code (ORC) 3709.085, the Clermont County Health District finds it necessary to adopt local air pollution control regulations consistent with ORC Chapter 3704 and Ohio Administrative Code (OAC) 3745-14 through 3745-24, 3745-31, 3745-73, 3745-76, 3745-77 through 80, 3745-100 through 104, 3745-107, and 3745-110 through 114; complete text of these regulations can be found at <https://epa.ohio.gov/divisions-and-offices/air-pollution-control/regulations/effective-rules>; and

WHEREAS, the Secretary of the District shall make copies of Ohio Revised Code Chapter 3704 and Ohio Administrative Code 3745-14 through 3745-24, 3745-31, 3745-73, 3745-76, 3745-77 through 80, 3745-100 through 104, 3745-107, and 3745-110 through 114 available for distribution to the public at a reasonable fee.

NOW, THEREFORE, BE IT RESOLVED by the Board of Health of the Clermont County General Health District that Ohio Revised Code Chapter 3704 and Ohio Administrative Code 3745-14 through 3745-24, 3745-31, 3745-73, 3745-76, 3745-77 through 80, 3745-100 through 104, 3745-107, and 3745-110 through 114 are hereby incorporated by reference as the Clermont County Health District Local Air Pollution Control Regulations, be adopted, effective November 1, 2024.

NOW, THEREFORE, BE IT FURTHER RESOLVED, by this Board of Health of the Clermont County General Health District, that this resolution be published on the Clermont County General Health District, dba Clermont County Public Health website and all social media accounts once a week for two consecutive weeks and that the first publication takes place no later than ten days prior to the effective date of the revision adopted herein.

NOW, THEREFORE, BE IT FURTHER RESOLVED that this Board of Health of the Clermont County General Health District find and determine that all formal actions relative to

the passage of this resolution were taken in an open meeting of this Board and that all deliberations of this Board and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance of the applicable legal requirements, including section 121.22 of the Ohio Revised Code.
